Will

Making Singapore General Hospital a beneficiary of your will is one way to make a lasting gift.

Your bequest can be for a specific sum of money or a percentage of your estate, done by simply including the following sentence in your will.

I, [Full name as per NRIC], give, devise and bequeath [insert dollar amount, property to be given, percentage of the estate] to Singapore General Hospital Pte Ltd (UEN 198703907Z), a company incorporated in Singapore to be used for its general purpose, free from all duties.

Central Provident Fund (CPF)

You can also nominate Singapore General Hospital as the beneficiary for your CPF savings by filling in the nomination form together with the following details:

If you are in an enviable position to reframe your priorities and do not need the payouts from your **CPF Life**, you can consider donating your monthly payouts to help someone in need.

- Consider and decide your gift amount from your monthly CPF Life payout
- 2. Instruct CPF Board to deposit your CPF Life monthly payouts to your designated bank account once you reach age 65.
- A month after you see your first payout, simply apply to donate it via GIRO from this same account to SGH.
