

Basic Aural Habilitation for Professionals

Introduction

The 1-week long programme will introduce the Auditory-Verbal Approach to professionals who are working with children with hearing loss. It is also useful for professionals who have an interest in finding out more about habilitation work with these children. This is a foundation level course which will prepare participants who are interested to be mentored in their practice, as they work towards their LSLS Cert AVT qualifications.

Course Objectives

- Learn about the Philosophy and Principles of the Auditory-Verbal Approach.
- Learn the Theoretical Framework and Goals of the Auditory-Verbal Approach.
- Learn Strategies and Techniques to use for Developing Listening and Spoken Language in Children with Hearing Loss.
- Learn about the different types of Assessments done in Auditory-Verbal Therapy.
- Learn how a Auditory-Verbal Therapy Session is planned and conducted.
