A/Prof Leslie Lim is a Senior Consultant, Department of Psychiatry, Singapore General Hospital. He is a Clinical Associate Professor at the National University of Singapore and an Adjunct Associate Professor at the Duke-NUS Medical School. He graduated MBBS (University of Singapore), trained in Psychiatry at St George's Medical School, University of London, obtained Membership of the Royal College of Psychiatrists, was elected Fellow of the Royal College of Psychiatrists (UK), and Fellow of the Academy of Medicine, Singapore. He was visiting scholar at the Memorial Sloan Kettering Cancer Centre, USA and at the Duke University Department of Psychiatry and Behavioral Sciences, North Carolina, USA.

He was President of the Singapore Association for Mental Health and presently serves as council member of the College of Psychiatrists, Academy of Medicine, Singapore. He was chief examiner in Psychiatry for the Master of Medicine in Psychiatry Examinations, and is presently an examiner at the local undergraduate and postgraduate examinations as well as with the Royal College of Psychiatrists, United Kingdom. For his contributions to Psychiatry he was awarded the Distinguished Psychiatrist Award by the Singapore Psychiatric Association in 2016.

Mr Ng Boon Tat is a Principal Pharmacist (Specialist) with the Institute of Mental Health (IMH). He attained his Postgraduate Certificate in Psychiatric Therapeutics (with Distinction) with Aston University (UK) in 2005, followed by the Master in Clinical Pharmacy with the University of South Australia, and became US board-certified in Psychiatry, Geriatrics and Pharmacotherapy. In 2010, he completed his year-long intensive advanced training in Psychiatric Pharmacy Practice with the University of Southern California, and returned to set up the PGY2 Psychiatric Pharmacy Residency Programme in Singapore.

He runs the Clozapine Clinic collaboratively with psychiatrists since 2011, and provides psychopharmacotherapy consultations for complex and treatment-resistant psychosis and mood disorders. He serves in the IMH Institutional Research Review Committee and also reviews manuscripts for local and international biomedical journals. As a clinical education lead, he contributes to interprofessional education and faculty development at the cluster and national levels.
