Introduction

To ensure a value-added clinical supervision, clinical supervisors need to be effective and efficient in supervisory skills. Organised by SGH-PGAHI in collaboration with SingHealth Allied Health Practitioners, this course aims to develop skills in supervising both students and staff in a clinical setting, especially for the new supervisors in first few years of their supervising role.

Using an evidence-based approach, this course will cover various frameworks, teaching and learning models and theories, and the application of these models to establish a robust clinical education/supervision culture within health services institutions.

- Describe and demonstrate the application of Proctor's Model of Supervision
- Explain supervisory styles and supervision effectiveness
- Apply SMART Concept to crafting of "Learning Contract"
- Grow the learner through effective feedback
- Identify Burnout and develop Self-Care strategies
- Facilitate reflection using Gibb's Model of Reflection
