

Applied Suicide Intervention Skills Training 12 - 13 March 2020

Introduction

Applied Suicide Intervention Skills Training (ASIST) was founded by LivingWorks Education Inc. in Calgary, Canada. It is a two-day intensive course designed to help frontline gatekeepers and professionals recognise and assist persons at risk of suicide using an effective suicide intervention model.

Course Objectives

At the end of the workshop, participants will be able to acquire knowledge and skills to deal with person at risk of suicide with greater confidence and competence.

Participants are required to fulfill 100% attendance rate in order to receive the certificate at the end of Day 2 of the course.

Day One:

- Introduction Module
- Sets the tone, norms & expectations of the learning experience.
- Attitudes Module
- Sensitises participants to their own attitudes towards suicide. Creates an understanding of the impact that attitudes have on their intervention process.
- Knowledge Module
- **Provides knowledge** & skills to recognize & assess the risk of suicide.

Day Two:

- Intervention Module
- Presents a model for effective suicide intervention. Participants develop their skills through observation, supervised simulation experiences & role-plays.
- Resources Module
- Generates information about resources in the local community. Promotes a commitment by participants to build local resources into helping networks.
