

Physiotherapy Management of Parkinson's Disease 1 – 14 February 2022 (Self-paced Online Learning)

15, 16 & 18 February 2022 (Live Zoom)

Introduction

This course aims to provide participants with an opportunity to increase their knowledge and understanding of current evidence-based assessment and management of people with Parkinson's disease (PD) within a multidisciplinary setting. It also covers the use of movement strategy training to address gait, freezing and mobility issues, and design of effective treatment programs including exercise classes for people with PD. This course comprises lectures, demonstrations and case discussions; all via Zoom. Each participant is expected to bring a case study of a patient with PD encountered in clinical practice (if possible) and apply the principles learnt during the case reviews.

Course Objectives

At the end of the course, participants should be able to:

- 1) Discuss the pathophysiology of Parkinson's disease (PD).
- 2) Differentiate between PD and other atypical parkinsonian syndromes.
- 3) Discuss the medical management of people with PD.
- 4) List the criteria for deep brain stimulation.
- 5) Discuss the non-motor symptoms of PD and their impact on patients and caregivers.
- 6) Perform a competent physiotherapy assessment of the patient with PD.
- 7) Discuss the rationale underlying various treatment approaches in people with PD. These include resistance training, cognitive movement strategies and use of cues.
- 8) Design and implement treatment programs for people with PD using an evidence-based approach. This includes identifying individuals who are at risks of falls.
- 9) Design and conduct comprehensive exercise classes for people with PD .
