

Physiotherapy Management of Spinal Cord Injuries 6 - 8 May 2019

Introduction

The focus of this course will be on rehabilitation strategies for people with spinal cord injuries although many of the key principles will be applicable to people with different types of neurological conditions. The course will be structured around a five-step process, namely assessing; setting goals; identifying key problems; administering treatments; and measuring outcomes. Time will also be devoted to learning about appropriate mobility goals for people with different levels of injuries and the implications of different patterns of paralysis on movement.

Course Objectives

- describe typical patterns of motor loss and function for people with varying levels of spinal cord injury (SCI)
- list the key movement strategies used by people with SCI to mobilise
- conduct a neurological assessment according to the International Standards for Neurological Classification of SCI
- demonstrate different strategies teaching for wheelchair skills
- argue the pros and cons of stretch/passive movements for effective contracture management
- develop an appropriate strength training program
- demonstrate treatment options for the management of respiratory complications
- summarise the evidence for different gait training approaches
