## Introduction

Singapore is facing a rapidly ageing population. The number of elderly citizens aged 65 years and above, is expected to double from 440,000 in 2015 to over 900,000 in 2030. To support the increased healthcare needs by the ageing population, the Ministry of Health has launched several action plans under the "Healthcare 2020 Master Plan" to transform healthcare service delivery. Some of these action plans include enhancing geriatric capability in acute hospitals, implementing initiatives to better support our seniors to age-in-place and improving the quality of palliative care.

As Singapore continues the journey to transform the model of care, there is a growing importance to prepare the pharmacy workforce to meet the specialized needs of this special population in acute and long term care as well as community setting. Pharmacists can collaborate within and beyond pharmacy community to provide team-based holistic care, such as optimizing medication therapy management, vaccinations and provision of palliative care.

## Objectives

- Discuss the role of pharmacists in geriatric care across the continuum of care (hospital & aged care facilities).
- Recognize the various geriatric assessment tools in clinical assessment of the older adults.
- Identify challenges in managing psychiatric symptoms in old adults and design appropriate pharmacotherapeutic plan to ensure safe and effective use of medications in the geriatric population.
- Explore opportunities for health-related needs in the ageing population such as palliative care and vaccinations.

## Teaching Faculty

**Dr Dennis Seow, MBBS, MRCP (UK), FRCP (Ed), FAMS (Geriatric Medicine)**

Dr Dennis Seow is a Senior Consultant and Head of Department at the Department of Geriatric Medicine (GRM), Singapore General Hospital (SGH). He is the Clinical Lead for the SGH GRM Memory Clinic and is the current SGH Representative for National Advanced Care Planning Steering Committee under the Agency for Integrated Care (AIC), Singapore. He has recently been instrumental in revamping the Orthopaedic-Geriatric Medicine service in SGH which integrates the Geriatric Medicine, Rehabilitation and Community Hospital Services to provide seamless care for hip fracture patients. His interests are assessment of cognitive disorders in the older person, interventions to aid caregivers of persons with dementia (including the use of technology), advance care planning, end of life care in dementia and delirium in the frail older person.

**Ms Tan Keng Teng, BSc (Pharmacy) (Hons), MSHPEd, BCGP**

Ms Tan Keng Teng is a Clinical Geriatric Pharmacist at Tan Tock Seng Hospital.
