

Anticoagulation Management 22 - 23 March 2021

Introduction

The virtual anticoagulation course comprises two components.

1) Self-paced online learning modules by distinguished experts sharing key concepts and updates in anticoagulation testing, monitoring, reversal, clinical management and service evaluation.

2) A two-day interactive session with experienced clinical facilitators who will share the practical aspects and practice pearls in anticoagulation management. During this session, the participants will have the opportunity to put their acquired knowledge into practice.

Course Objectives

- Understand the various coagulation tests used for monitoring of anticoagulants including the clinical uses and limitations.
- Describe the key differences between the pharmacology and pharmacokinetics of oral anticoagulants and their therapeutic applications.
- Develop a management plan for warfarin and direct oral anticoagulants in patients with various thromboembolic conditions.
- Evaluate the use of anticoagulants and antiplatelet for the management of cardiovascular conditions and stroke.
- Evaluate the use of anticoagulants in special populations such as elderly, pregnancy and renal impairment.
- Establish and evaluate the performance of a new anticoagulation service and adapting with new care delivery during the COVID-19 pandemic.
