

# Clinical Reasoning Approach to Pharmacotherapy 1 August 2020

#### Introduction

Clinical reasoning is broadly described as the cognitive process through which practitioners apply their knowledge and clinical experience to assess and manage a patient's condition. An integrated clinical reasoning model is essential to enhance the practitioner's clinical reasoning skills in the delivery of patient care.

## **Course Objectives**

- To understand the concepts and components of clinical reasoning.
- To apply the components of clinical reasoning in daily pharmacotherapy practice for management of chronic diseases such as diabetes, hypertension and thyroid disorders.
- To create awareness of the impact of clinical reasoning on patient care.

The course focuses on developing the clinical reasoning skills in pharmacotherapy of chronic diseases. The proposed model shall integrate both clinical reasoning processes and SOAP processes using case-based discussions.
